<u>Information clause of the personal data controller – University candidates / students,</u> who have not attained the age of 18 yet and their statutory representative:

Pursuant to the Regulation (EU) 2016/679 of the European Parliament and the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC – General Data Protection Regulation, hereinafter referred to as: **GDPR** (OJ EU L. of 2016, No 119, item 1, as amended), **we would like to inform** that the lawfulness of the processing complies with the requirements provided for in Article 6(1)(a) of GDPR (granting your consent), in Article 6(1)(b) of GDPR (the necessity for the performance of a contract), Article 6(1)(c) of GDPR (legal obligation of the controller) or Article 6(1)(f) of GDPR (legitimate interests pursued by the controller) and that:

- 1) the Controller of your personal data, referred to in section 4, is the University of Economics in Katowice, with its main office at the following address: 1 Maja 50, 40-287 Katowice, hereinafter referred to as: the "Controller";
- 2) the Controller appointed a Data Protection Officer to supervise the accuracy of the processing of personal data, who may be contacted at the address: iod@ue.katowice.pl;
- 3) the personal data of the following categories of persons will be subject to processing: *University* candidates / students who have not attained the age of 18 yet and their statutory representative;
- 4) the processing will pertain to the necessary personal data of the categories of persons referred to in section 3, provided for in applicable provisions of law, e.g.: in the case of University candidates / students, who have not attained the age of 18 first name(s), surname, signature, photo, date and place of birth, PESEL No (if none name and number of an identity document and the name of the issuing country), place of residence and address for service, place of residence before commencing the program: village or town/city, sex, nationality, in the case of non-nationals also the name of the country of birth and information on whether they hold the Pole's Card, personal data contained in their personal file and other documents necessary to pursue objective referred to in section 6, and in the event of applying for additional aid personal data necessary to obtain it (in particular, the information on the family status and the property), in accordance with applicable provisions of law, and in the case of their statutory representatives first name(s), surname, signature, place of residence, name and number of an identity document and the name of the issuing country, contact phone number, e-mail address and other documents necessary to pursue the objectives referred to in section 6;
- 5) the provisions of the personal data in the scope required under the provisions of law is obligatory and necessary to pursue the objectives referred to in section 6, otherwise, the provisions of personal data is voluntary, and the refusal to provide the personal data may result in the objectives failing to be fulfilled;
- 6) your personal data referred to in section 4 shall be processed for, among others, the following purposes: the recruitment process to be enrolled on a program / course, recording the course of studies / courses, completion of the training process, calculating and paying aid (in particular, awards and scholarships), the Controller performing their information, archiving and statistical obligations, direct communication, performing any activities connected with these purposes (among others, by informing of being enrolled on and participating in programs / courses, sending invitations and information on current events to the participants), protecting the interests of the Controller (including, potential damages arising in connection with the performance of these purposes or protection against such claims) and maintaining proper documents;

- 7) it is mandatory for the Controller to store your personal data referred to in section 4, pursuant to the applicable provisions of law and stemming from the performance of the purposes referred to in section 6;
- 8) it is not intended for the personal data referred to in section 4 to be processed for purposes other than the purpose for which they were collected, as referred to in section 6;
- 9) the recipients of your personal data referred to in section 4 are the authorized employees of the Controller, in certain cases also processors on behalf of the Controller and entities authorized to obtain the personal data under the applicable provisions of law;
- 10) your personal data referred to in section 4 shall be processed and stored by the time the legal obligation stemming from the applicable provisions of law in this respect are in effect, i.e. for the period necessary to fulfill the purposes referred to in section 6 and for the period provided for in the applicable provisions of law to pursue claims;
- 11) you have the right to access your personal data referred to in section 4 and the right to: rectify, delete (provided it is permissible), limit their processing, transfer or object thereto, and the right to withdraw your consent to processing at any time, without affecting the lawfulness of the processing, when the basis for the processing of the personal data is the consent of the person who granted it;
- 12) you have the right to submit a complaint to a supervisory authority, that is the President of the Personal Data Protection Office, when you are of the opinion that the processing of your personal data infringes upon the provisions of GDPR;
- 13) your personal data referred to in section 4 shall not be processed in an automated manner, which includes profiling;
- 14) your personal data referred to in section 4 shall not be transferred to a third country / international organization, unless it is required under the legal obligations of the Controller.
